
## JOIN US FOR AN ENVISION 2050 FORUM!

On March 22, 2023, Northern Middlesex Council of Governments will host the Envision 2050 Public Forum 2. This event will be a hybrid event via Zoom, in-person attendees may join us at the UMASS Lowell Wannalancit Mills building from 6pm-7:30pm. During the meeting, NMCOG Transportation staff will summarize public outreach efforts with municipalities and partners, and present the latest Envision 2050 survey results helping shape the development of the Envision 2050 plan. The meeting will include a review of the plan goals and performance based planning work by the MPO, addressing these goals. We have received financial insights on federal allocations for the region, and this meeting will be an opportunity to share those numbers with the public.

### PLANNING AHEAD FOR NMCOG AND THE REGION

NMCOG is planning for the agency's future! The NMCOG Council kicked off the process on January 28th at the Chelmsford Public Library in a session with 12 Council member and facilitated by Jennifer Raitt, Executive Director. The session included time for councilors to get to know each other, a presentation about the history and role of NMCOG as a regional planning agency, current NMCOG initiatives and staffing, and the need for a strategic plan for the organization. The group discussed the mission and values of NMCOG and group members also expressed their concerns and hopes for a strategic plan for the agency. The planning process will include focus groups and stakeholder interviews to better understand NMCOG's historic and current organizational conditions, the direction the agency should head in for the next three years, and ways that the agency can improve delivery of a range of services to the region. A second retreat will be planned in the spring of 2023 to learn about emerging themes and set the stage for discussing NMCOG's mission, statement of values, and priorities.




## GRANT OPPORTUNITIES THROUGH THE INFLATION REDUCTION ACT AND INFRASTRUCTURE INVESTMENT AND JOBS ACT

The following federal grant opportunities funded through the Infrastructure Investment and Jobs Acts (IIJA), the Inflation Reduction Act, and other federal sources were recently announced and are now available:

- Environmental Justice Gov-2-Gov AND Cooperative Problem Solving (EPA)
- Lead Hazard Reduction & Housing-Related Hazards Programs (HUD)
- <u>Targeted Violence and Terrorism Prevention Program (DHS)</u>

Additionally, the Environmental Protection Agency (EPA) announced an additional allocation of \$2 billion dollars for the Emerging Contaminants (EC) in Small or Disadvantaged Community (SDC) Grant program. This will bring an additional \$38 million dollars to the Commonwealth to support local projects addressing emerging contaminants like Per- and Polyfluoroalkyl Substances (PFAS) in drinking water. #### THE INFLATION REDUCTION ACT AND HOUSING



The Inflation Reduction Act is providing for billions in funding for communities across the US for a range of programs and projects that relate to all aspects of our municipalities from municipal buildings to roads to housing. There are a number of programs that will help housing, specifically in relation to climate resiliency. For example, the Greenhouse Gas Reduction Fund will provide \$27 billion in grants for reduction projects in low-income or historically disadvantaged communities and \$1 billion will help state and local governments adopt and implement updated energy codes, such as the state's new net zero stretch energy code.
