NMCOG Announces Funding Awards for Technical Assistance

The Northern Middlesex Council of Governments (NMCOG) is pleased to announce over \$800,000 in technical assistance across the region to the City of Lowell and the Towns of Billerica, Chelmsford, Dracut, Dunstable, Pepperell, Tewksbury, Tyngsborough, and Westford addressing housing, energy and sustainability, economic development, and transportation.

In early spring 2023, NMCOG distributed a request for assistance proposals to the nine communities and awarded a total of 32 projects. These local projects are funded by multiple sources, including the District Local Technical Assistance (DLTA) Program through the Massachusetts Department of Housing and Community Development (DHCD). In addition, seven regional projects serving all communities were awarded assistance primarily through the DLTA program, supplemented by other sources.

Additionally, as staff to the Northern Middlesex Metropolitan Planning Organization, NMCOG will also be utilizing federal transportation funds to provide regional technical assistance to member communities through the Unified Planning Work Program.

Nearly all projects seek to advance equity and ecological sustainability in the region. Many will include working with communities on innovative outreach strategies to increase inclusivity of the process and actively solicit and respect input from people with diverse lived experiences.

NMCOG intends to release a second request for proposals, this one focused on assistance with capacity-building related to prioritization of projects and grant seeking, writing, and managing. This call is anticipated to be released in early summer 2023. More information on specific awards and the full announcement is available at www.nmcog.org.

NMCOG Awarded Grant from the Greater Lowell Community Foundation

NMCOG was one of 19 organizations awarded **funding from the Greater Lowell Community Foundation** as part of their discretionary grant funding cycle in the spring of 2023. The \$15,000 grant was made under the category of Racial Equity and Inclusion. The funding will support the outreach and engagement as part of the development of the *At Home in Greater Lowell: Regional Housing Strategy Plan through 2035.* NMCOG is excited to begin working on this plan in 2023 and looks forward to robust and creative engagement as we focus on improved quality of life in our region and increased availability, affordability, and attainability of housing for all. MassDOT Funding Opportunity

A Notice of Funding Opportunity for Age-Friendly Funding Alert MassDOT Community Transit Grant Program became available today. MassDOT's annual Community Transit Grant Program (CTGP) offers funding for transit authorities, municipalities, Councils on Aging, and nonprofits to expand mobility for older adults and people with disabilities. In order to give you all a chance to participate, we wanted to share this message early. The Community Transit Grant Program (CTGP) awards funds to help meet the transportation and mobility needs of seniors and people with disabilities. The annual competitive program distributes Federal Transit Administration (FTA) Section 5310: Enhanced Mobility of Seniors & Individuals with Disabilities funds and State Mobility Assistance Program (MAP) funds.

MassDOT will provide two trainings on May 8 (1-3PM) to learn about applying for funding through MassDOT's Community Transit Grant Program. Applications for operating and mobility management projects will open **May 8 and close June 23.**
