

The plan will identify the most significant roadway safety concerns in the region and specify projects and strategies to implement to address roadway safety issues. Northern Middlesex MPO Endorses Envision 2050: The Long Range Transportation Plan

On August 23, 2023 the NMMPO voted to endorse the Envision 2050, the Long Range Regional Transportation Plan. Envision 2050 is the comprehensive and equitable vision for the future of transportation in the Northern Middlesex region; it identifies and analyzes transportation infrastructure and service improvement needs for the region's transportation system, serves as the policy framework for future investment in our roadway, transit, bicycle and pedestrian network, and serves to position the region for future housing, economic development, and mobility-related projects. On Wednesday, August 23rd, Sustainability Planner
Dany Garcia Moreno attended a special press
conference hosted by Senator Markey and EPA
Administrator Michael Regan kicking off the National
Clean Financing Network. The National Clean
Financing Network will receive \$14 billion and provide

two to three grants to National, clean financing institutions. These institutions will partner with the private sector to provide direct support to individuals, families, businesses and governments to implement widespread clean technology projects. Created under the Bipartisan Infrastructure Law, the SMART Grants Program funds purposedriven innovation to build data and technology capacity and expertise for State, local, and Tribal governments. Approximately \$50 million will be allocated to communities that target their real-world challenges where the use of new technologies and approaches can create benefits. Eligible transportation projects should demonstrate at least one of the following technology areas: coordinated automation, connected vehicles, sensors, systems integration, delivery/logistics, innovative aviation, smart grid, or traffic signals. Applications are being accepted through October 10. Learn more and apply.

Safe Routes to School Signs and Lines Infrastructure Grants Application Period Open

MassDOT is inviting grant applications for the Safe Routes to School (SRTS) Signs and Lines Projects through Friday, September 22, 2023. The SRTS Signs and Lines Program will provide design services and up to \$10,000 in construction funding to a selected municipality for a low-cost infrastructure project around a public elementary, middle, or high school. The goal of these projects is to eliminate small barriers that students encounter when walking, bicycling, or using a wheeled mobility device to get to school. Governor Healey Kicks off FY24 Community Compact Program: Apply for Best Practices and Community Compact IT Programs This Month!


The Healey-Driscoll administration recently announced the commencement of the FY24 Community Compact program. The application window for the Best Practices program is now open, and the Community Compact IT Grant Program will begin accepting applications on September 11.

Best Practices Program

The Community Compact Best Practices Program is a voluntary, mutual agreement entered into between the Healey-Driscoll Administration and individual cities and towns. In a Community Compact, a community will agree to implement at least one **best practice that they select from across a variety of areas**. The community's chosen best practice(s) will be reviewed between the Commonwealth and the municipality to ensure that the best practice(s) chosen are unique to the municipality and reflect needed areas of improvement. Applications are accepted on a rolling basis and will be reviewed within one month of submission. **Learn more and apply.**

Community Compact IT Grant Program

This is a competitive grant program focused on driving innovation and transformation at the local level via investments in technology. Using the transformative powers of IT, communities can drive innovation, make government more efficient, save taxpayer money, and make it easier for residents to interact and transact with their local government. The application period will run from September 11, 2023 to noon on October 13, 2023. Cities and towns that were awarded an IT Grant Program grant in FY23 are not be eligible in FY24. Blake Acton, Regional Transit Planner II

Blake joined NMCOG in August 2023; his primary responsibility is to support the Lowell Regional Transit Authority (LRTA). This includes maintaining transit system data, ensuring compliance with federal and state requirements such as Title VI, Federal Transit Administration, Americans with Disabilities Act, and National Transit Database reporting. He also conducts analyses of ridership trends and operations and serves as a liaison with municipalities, regional partners, and advocacy organizations.

Before joining NMCOG, Blake was a transit analyst at the Boston Region Metropolitan Planning Organization where he led projects on curb management and assisted the MBTA with updating their Title VI policy and conducting equity analyses. Blake holds a B.A. in geography from the University of Missouri and an M.A. in transportation geography in 2020 from The Ohio State University.



Austen Torres Davis, Transportation Planner II

Austen joined NMCOG in August 2023; he serves as staff support to the Northern Middlesex MPO to advance goals and performance measure requirements of US DOT and MassDOT. His work includes monitoring and assessing pavement conditions, safety and security, as well as system performance of the regional transportation network. This work guides infrastructure project prioritization, safety improvement strategies and emergency management, as well as congestion mitigation.

Prior to joining NMCOG, Austen was a Planner for the City of Portland, Maine, where he reviewed development and re-zoning proposals for compliance with Portland's Land Use Code, created data visualizations and outreach to facilitate bicycle and pedestrian infrastructure projects, and managed the City's program for temporary public art. Austen received a B.A. in Geography and Urban Studies from Temple University and a Master's in Regional Planning from Cornell University.
